Destrehan Plantation Festival Craft Entry Rules

Festival Dates: Saturday & Sunday, November 14th & 15th, 2026—9 am – 4 pm

Destrehan Plantation requires all vendors to sell handcrafted items, and we request all vendors, new and returning, to complete an application and list items to be sold in your booth. We asked that new vendors submit photos of their handcrafted items for approval.

Art work sales are limited to original art work, limited edition signed prints, and matted and framed art. Destrehan Plantation does not allow the sale of mass produced, unframed art. No exclusive rights on sale of any items. We will, however, try to limit duplication. State gaming laws prohibit raffles.

Vendors must submit the total fee with the application. We accept checks, money orders and Venmo.

Each booth is for one vendor and will be in the name of that vendor. Vendors provide and set up their own tents. Approval is required from our chairperson for vendors with self-contained trailers. We do solicit volunteers to assist you with booth setup, but cannot promise volunteers will be available for everyone. One parking pass will be furnished per booth, and each booth entitles entrance for two (2) people. The assistant chairperson distributes parking passes, worker badges and necessary tax forms the day of set-up. **Please remember you are responsible for collecting and paying both parish and state sales tax.**

FRIDAY SETUP: Maintenance personnel opens gates at 8:00 am for vendor set-up. Once unloading is complete, please remove your vehicle from the gate and park it in the parking lot closest to your booth. You may continue set-up until 5:00 pm.

SATURDAY SETUP: You may begin set up at 7:00 am.

SUNDAY NIGHT: Vehicles are not allowed on grounds during removal of merchandise. Please make necessary arrangements to provide handcarts, wagons or other equipment for the removal of your merchandise.

Because of liability, Destrehan Plantation does not allow animals on the grounds for the Fall Festival.

Destrehan Plantation sets the above rules for safety and success of the festival. We ask that you obey all rules.
